## TERMS AND CONDITIONS (NOT-FOR-REALE)

I hereby submit my Application to participate in MonaVie's Compensation Plan. These Terms and Conditions are incorporated into my Application. MonaVie may accept or refuse my Application at its own discretion. I certify that I am old enough to enter into an enforceable contract in my jurisdiction of residence.

1. Parties. I understand that I am contracting with MonaVie Hong Kong, Ltd. ("MonaVie") for the purchase of its products and the right to participate in its compensation plan, and with MonaVie Exporting, Inc., a U.S. company. MonaVie Exporting, a MonaVie affiliated entity, has the responsibility to promote the sale of Products internationally.
2. Agreement. Unless otherwise defined herein, all capitalized terms shall have the same meaning assigned to such terms in the Policies and Procedures. The term "Agreement" shall mean the Consumer Application (of which these Terms and Conditions are a part of, the Compensation Plan, and the Policies and Procedures and any country or situation-specific addendum(s) thereto, and any other written agreement between the Consumer and MonaVie. I hereby agree to be bound by the Agreement.
3. Compliance with Laws. I agree to comply with all applicable laws relevant to conduct of my activities as Consumer and participant in the Compensation Plan under this Agreement. In particular, and without limitation, I must not make any actual or potentially misleading or deceptive claims in relation to commissions and other rewards that might be derived from conducting activities as a participant in the Compensation Plan and as a Consumer of MonaVie products.
4. Rights. I understand that as a Consumer, I have the right (but not the obligation) to:
  - a. buy products from MonaVie in accordance with these Terms and Conditions in such manner as MonaVie may from time to time allow in relation to its Consumers generally;
  - b. recommend persons for acceptance as MonaVie Consumers (subject to acceptance by MonaVie);
  - c. if qualified, earn bonuses and other rewards pursuant to the Compensation Plan that will be awarded on the same basis as it allows to its Consumers generally in respect of legitimate sales of MonaVie products, and not in respect of the mere introduction of new Consumers to MonaVie.
5. Product Returns. I understand that I can return Products I purchase pursuant to the Policies and Procedures.
6. Independent Contractor. I agree that as a MonaVie Consumer I am an independent contractor, and not an employee, partner, legal representative, or franchisee of MonaVie. I agree that I will be solely responsible for paying all expenses incurred by myself, including but not limited to travel, food, lodging, secretarial, office, long distance telephone and other expenses. I UNDERSTAND THAT I SHALL NOT BE TREATED AS AN EMPLOYEE OF MonaVie FOR ANY PURPOSE.
7. Bonus Payments. I understand that I must not be in breach of the Agreement to be eligible to receive Bonuses pursuant to the Compensation Plan.
8. AutoShip. I may elect to have Product sent to me monthly on an automatically processed order (AutoShip). To change any detail pertaining to my AutoShip order, my phoned request or my written request (from my email account of record or via regular mail and signed by me) must be received by MonaVie 72 hours in advance of the next shipment. I may change my AutoShip order in my Virtual Office. All orders are subject to applicable VAT, which is included in the order price. Shipping & handling charges will also be added. The credit card listed on my account will automatically be charged for this order. Orders in which the payment method is declined may not be processed. Attempts may be made by MonaVie to reprocess the order should my payment method decline; however, MonaVie makes no assurances that these attempts will be made. If a credit card is due to expire, I acknowledge that my issuing bank may update my expiration date automatically, which will allow MonaVie to process my order payment; however, I agree to be responsible for providing current payment. I agree that MonaVie reserves the right to change my AutoShip orders to subsequent payment methods added by me if my first payment method declines. The charge sequence will be in the order that I list my payment methods in my MonaVie virtual office.
9. If an order cannot be processed due to payment difficulties, MonaVie will not be held responsible for personal volume shortfalls.
10. Privacy. MonaVie is committed to collecting and using personal information in a fair and lawful manner, ensuring its accuracy, keeping personal information only for lawful purposes, not using or disclosing such information in a manner incompatible with such purposes, and taking appropriate security measures against unauthorized access, disclosure or destruction in accordance with the provisions of any legislation regarding personal information in the country I am operating in. In addition to the personal information provided by the Distributor in connection with its application to become a Distributor, the Distributor acknowledges that other personal information will be collected by MonaVie, including information generated as a result of its work as a Distributor, such as sales figures and other performance details photographs, advancement information, status, or other business related information collectively referred to as "Personal Information"). I acknowledge that the Personal Information will be retained by MonaVie and will be used by MonaVie for marketing and other administration purposes. I acknowledge that MonaVie may from time to time disclose this Personal Information in connection with such purposes to other members of MonaVie's group and to other Distributors, all of whom may communicate with me, including by way of electronic messages. I consent to MonaVie collecting, retaining, processing and disclosing Personal Information referred to above. Such information will be held by MonaVie. I understand that I have rights of access to, and correction of, this information
11. Amendments. MonaVie may be required to amend the Agreement from time to time. MonaVie agrees to notify me of the amendments.
12. Cancellation. I understand that I may cancel this Agreement, without penalty, within 14 days of entering into it and that if I do so I am entitled to recover all monies paid to MonaVie. Cancellation must be effected by sending written notice to MonaVie via email to thailand@monavie.com. I acknowledge that the email notice must be from my email of record and include my name, Customer identification number, password, and address.
13. Term and Termination. The term of this Agreement is one year, subject to earlier termination in accordance with this Agreement or in accordance with law. If this agreement is not renewed, or if it is terminated for any reason, I understand that my right to purchase MonaVie products and receive bonuses will cease. MonaVie reserves the right to terminate this Agreement if (i) AFTER NINETY (90) DAYS FROM ITS ACCEPTANCE IF I HAVE NOT ORDERED ANY PRODUCT OR SPONSORED ANOTHER DISTRIBUTOR or if (ii) at any time upon 30 days notice if the Company elects to:
  - (1) cease business operations;
  - (2) dissolve as a business entity;
  - (3) terminate distribution of its products via direct selling channels, or (iii) at any time upon not less than 7 days notice and without further notice if I breach this Agreement and fails to remedy the breach before the end of the notice period. . I may cancel this

Agreement at any time, and for any reason, upon written notice to MonaVie at [compliance@monavie.com](mailto:compliance@monavie.com).

14. No Assignment. I may not assign any rights under the Agreement without The prior written consent of MonaVie. Any attempt to transfer or assign the Agreement without the express written consent of MonaVie renders the Agreement voidable at the option of MonaVie and may result in termination of my business. MonaVie may assign the Agreement to an affiliate without my consent or giving me notice.
15. Release and Indemnification. To the maximum extent permitted by law, MonaVie, its parent or affiliated companies, directors, officers, shareholders, employees, assigns, and agents (collectively referred to as "affiliates"), shall not be liable for, and I release MonaVie and its affiliates from, all claims for consequential and exemplary damages for any claim or cause of action relating to the Agreement. I further agree to release MonaVie and its affiliates from all liability arising from or relating to: (a) my or any other Consumer's breach of the Agreement ; (b) the promotion or operation of a MonaVie business by me or any other Consumer and any activities related to it, including, but not limited to, the presentation of Products or the Compensation Plan, the operation of a motor vehicle, the lease of meeting or training facilities, etc., and agree to indemnify MonaVie and its affiliates for any liability, damages, fines, penalties, or other; (c) any incorrect data or information provided by me or any other Consumer to MonaVie; (d) my or any other Consumer's failure to provide any information or data necessary for MonaVie to operate its business; or (e) awards arising from any unauthorized conduct that I undertake. I further agree to indemnify MonaVie for any liability, damages, fines, penalties or other awards arising from any unauthorized conduct that I undertake pursuant to the Agreement.
16. Entire Agreement. The Agreement, in its current form and as amended by MonaVie constitutes the entire contract between MonaVie and myself. Any promises, representations, offers, or other communications not expressly set forth in the Agreement are of no force or effect.
17. Waiver. Any variation or waiver by MonaVie of any breach of the Agreement must be in writing and signed by an authorized officer of MonaVie. Waiver by MonaVie of any breach of the Agreement by me shall not operate or be construed as a waiver of any subsequent breach.
18. Severability. If any provision of the Agreement is held to be invalid or unenforceable, such provision shall be reformed only to the extent necessary to make it enforceable and the balance of the Agreement will remain in full force and effect.
19. Delays. MonaVie is not responsible for delays in the performance of its obligations under this Agreement when performance is made commercially impracticable due to circumstances beyond its reasonable control.
20. Governing Law. This Agreement will be governed by and construed in accordance with the laws of the State of Utah without regard to principles of conflicts of laws.
21. Dispute Resolution. All disputes and claims relating to MonaVie, the Agreement, or any other claims or causes of action relating to the performance of me or another Distributor shall be settled totally and finally by arbitration as set forth in the Policies and Procedures. Nothing in the Agreement shall prevent MonaVie from applying to and obtaining from any court having jurisdiction a writ of attachment, garnishment, temporary injunction, preliminary injunction, permanent injunction or other equitable relief available to safeguard and protect its interest prior to, during or following the filing of any arbitration or other proceeding or pending the rendition of a decision or award in connection with any arbitration or other proceeding.
22. Jurisdiction and Venue. The parties consent to jurisdiction and venue before any federal or state court in Salt Lake County, State of Utah, for purposes of enforcing an award by an arbitrator or any other matter not subject to arbitration. In the event of a dispute, the prevailing party shall be reimbursed attorney's fees and reasonable travel and accommodation costs by the other party.
23. Limitation of Action. If I wish to bring an action against MonaVie for any act or omission relating to or arising from the Agreement, such action must be brought within one year from the date of the alleged conduct giving rise to the cause of action. Failure to bring such action within such time shall bar all claims against MonaVie for such act or omission. I agree to waive all claims that any other statutes of limitations apply.
24. Successors and Assigns. The Agreement will be legal and binding upon and inure to the benefit of the parties and their respective successors and assigns.
